Overview

As California's governance and political systems become increasingly entrenched, actions by our state's policy makers often result in poorly drafted and ill-conceived initiatives. No matter what the cause, seeking litigation to protect the interests and integrity of public education has become a necessary interest of ACSA and its members. ACSA created the Education Legal Support Fund (ELSF) in 2006 in order to meet those needs.

In recent years, ACSA has been involved in numerous lawsuits impacting school districts and county offices statewide. These legal actions have included:

- Challenge to LAUSD mayoral takeover of schools (Statute invalidated)

Committed to Protecting Public Education and ACSA Members

ACSA's ELSF is needed more now than ever. We know litigation will be needed to challenge future attempts to impact school funding, retirement programs, special education decisions and a variety of challenges to school governance. It is imperative that the interests of education leaders are represented in these critical decisions.

Priority on Statewide, **Precedent Setting Issues**

ACSA's Education Legal Support Fund will prioritize its involvement in legislation, budgetary actions and initiatives that have a statewide precedent or impact on K-adult public education. In addition, any initiative, budgetary action, or legislation that usurps local control, changes the governance and oversight of school districts or violates Proposition 98 will be considered for legal action by the support fund.

All Districts and County Offices of Education can Participate

School districts and county offices of education are encouraged to join ACSA's Education Legal Support Fund, ACSA's Board of Directors serves as the steering committee to determine the fund's participation in various legal issues. An advisory committee comprised of ACSA leaders, school attorneys and superintendents provide oversight and guidance on litigation activities and general legal issues impacting K-Adult programs and services.
